COMPULSORY QUESTION

1. Aderongbe Chukwudi was arrested by men of the Nigeria Police Force on allegation of having stolen a Nokia 33 mobile phone set, property of Donatus Aniwura. Aderongbe Chukwudi has been detained at Oke-Eda Police Station Akure, located some 100 metres away from the premises of the Chief Magistrates' Court of Ondo State and the High Court of Ondo State, Akure Division for eight days. Despite several requests by Aderongbe Chukwudi that he be granted access to John Bamisaye. his lawyer, the Police refused him access to the said lawyer. On the 3rd day of his detention, Sunday Omorodion, the Investigation Police Officer (IPO) administered two hot slaps on Aderongbe Chukwudi and ordered him to make a statement stating that he stole the said Nokia phone. Afraid that more slaps might be administered on him by the IPO. Aderongbe Chukwudi made a statement in which he stated that he stole the said Nokia 33 mobile phone set. Mrs Ibironke Chukwudi, the wife of the suspect has now hired you as the suspect's lawyer and you have been instructed to approach the High Court of Ondo for the enforcement of Aderongbe Chukwudi's fundamental rights.

With reference to the relevant provisions of the Constitution of the Federal Republic of Nigeria 1999 (as amended), the Administration of Criminal Justice Law 2015 of Ondo State and case-law authorities, identify the fundamental and procedural rights of Aderongbe Chukwudi that were violated and on which your action will be based.

- 6. With reference to relevant provisions of the Constitution of the Federal Republic of Nigeria 1999 and statutes, enumerate seven examples of civil rights and five examples civil obligations alluded to in Section 36(1) of the Constitution of the Federal Republic of Nigeria 1999 (as amended).
